ReStore Operations

The Organization operated two ReStores, which sold donated building materials and gently used household goods and appliances to the public. ReStore revenue supports the Organization's ability to plan and execute its affordable housing programs and services. In addition, the ReStores provide a means of reusing and recycling goods that may otherwise contribute to local landfills. During FY24, the Organization's Restores diverted over 1,000 tons of household and construction materials from landfills.

Affordable Housing

The Organization's affordable housing programs include building new homes, repairing housing stock, and providing advocacy and education for low-income families. During FY24, the organization completed and sold 1 new home and began construction on two new homes. In addition, the organization completed 40 critical home repair projects. The Organization coordinates thousands of volunteers each year who assist in its mission of building, renovating, and repairing homes for families in need.
